2017	RFP 2017-109 was released for a Criminal Justice/Population Trend and Jail Needs Assessment. After interviewing different vendors, SMRT and CRS, Inc. were awarded the contract.

August 9, 2018	Jail Committee Kickoff Meeting - Sheriff Sheron and Matt Landers appointed as Chairpersons Steering Committee created. Started developing RFP for Architectural and Engineering Planning, Design and Construction Administration Services
September 1, 2018	RFP 2018-106 was released for Architectural and Engineering Planning, Design and Construction Administration Services for GC Jail Project
October 24, 2018	Meeting to discuss the 4 proposals and review score sheets of Committee Members. Finalists were chosen for interviews with Jail Committee
November 14, 2018	Jail Committee met with first finalist at the Sheriff's Admin Bldg. to review the RFP submission and ask additional questions. Follow up information was asked from the vendor.
November 15, 2018	Jail Committee met with second finalist at County Building II to review the RFP submission and ask additional questions. Follow up information was asked from the vendor.
November 29, 2018	Jail Committee met to discuss the finalists interviews and answers to follow up questions. It was determined that more information is needed from the finalists
January 7, 2019	Committee met to discuss the additional information that was submitted by finalists. Laura Wadhams and Matt Landers to develop a standard pricing structure for finalists to complete for the committee to do an "apples to apples" comparison
January 17, 2019	Committee deliberated between two finalists and voted on a vendor to recommend to the Legislature
February 19, 2019	Committee makes recommendation to the Public Service Committee for Architectural and Engineering Planning, Design and Construction Administration Services
